#### **2025/09 52 Consideration of correspondence received.**

The Clerk reported correspondence received from Pembrokeshire County Council regarding the closure of Penally Toilets, various options to consider, the Clerk to reply stating outcome of ongoing dialogue with Senior Officers of the County Council, in relation to present closure and promise made to re-open.

The Clerk reported detail received on the next round of funding from the Enhancing Pembrokeshire Grant, the Clerk to complete EOI with regard to the planned park projects. Cllr Kidney to enquire on previous request to the asset transfer of the playing field.

Cllr Snow reported that complaints received regarding noise and disturbance coming from the local Holiday Park, Cllr Kidney to invite the General Manager to future meeting of the Community Council.

#### **2025/09 53 County Councillor Philip Kidney report**

Cllr Kidney reported that the County Council have commenced the Budget setting process for the next financial year, currently projecting a £18 Million deficit. The consultation carried out by Hywel Dda on Hospital provision has closed findings and proposals expected in November. Planning officers receiving no response from owner of developing Plot on the Ridgeway, further actions to follow. An increase in general household waste being emptied into public bins at the Station Car Park, a plea that household waste should be collected from their property. If it continues bins may be removed.

Cllr Boyle reported that quotes are being sought for works to the entrance of the proposed Memorial Garden, in particular from Stone Masons. A meeting arranged with prospective contractor arranged.

Cllr Snow reported that the recent event in the Park raised over £600, Cllr Snow thanked fellow Cllrs for their support, further events planned.
